Abstract for *An Epistemological Argument for Moral Response-Dependence*How can we best account for the objectivity and normativity of moral reasons and requirements? A common answer is non-naturalistic moral realism, which posits irreducibly normative properties, facts, or truths as features of the mind-independent world. I develop a novel epistemological objection to this view, showing that we could never rationally decide to accept our ordinary moral beliefs if we took them to be about such things. I then examine how we might come to have reasons and requirements of non-moral kinds, including those related to game playing. I show how these reasons and requirements arise as constitutive parts of normative practices that we construct. This model is broadened to account for instrumental, epistemic, and moral normative truths.
